At 8 launch meetings between now and mid-February 2016, Hcéres will present the procedures and reference documents for the 2016-2017 evaluation campaign (Group C) to the relevant institutions and research bodies.

To this end, Hcéres is now publishing a dedicated section on the website, built around 4 main menus:

- **“Putting together my evaluation file”**: reference documents and list of the documents to be submitted;

- **“Viewing my evaluation reports and submitting my comments”**: information on procedures for consultation and submission via the [Hcéres Electronic Document Management application](#) [↗](#).
