Conclusions and Recommendations

The Commission has concluded that the alleged human rights violations and abuses by the Philippine National Police (PNP) and the Philippine Army (PA) against the victims and their families are grave and serious.

The Commission has also concluded that the PNP and the PA have failed to provide adequate and timely assistance and support to the victims and their families, and that the victims and their families have suffered significant physical, psychological, and economic harm.

Based on the findings of the Commission, the following recommendations are made:

1. The PNP and the PA should be held accountable for the alleged human rights violations and abuses.
2. The PNP and the PA should provide adequate and timely assistance and support to the victims and their families.
3. The PNP and the PA should take steps to prevent the recurrence of such violations and abuses.
